MONTHLY UPDATE ANNOUNCEMENT PURSUANT TO RULE 3.7 OF THE TAKEOVERS CODE

This announcement is made by Man Shun Group (Holdings) Limited (the “**Company**”) pursuant to Rule 3.7 of the Code on Takeovers and Mergers (the “**Takeovers Code**”).

Reference is made to (i) the announcement of the Company dated 10 July 2026 (the “**Announcement**”) in relation to, among others, the Letter of Intent which sets out certain preliminary terms in relation to the Possible Transaction regarding the possible sale of the Sale Shares indirectly held by the Vendors to the Potential Purchaser or such entities controlled by the Potential Purchaser, which may, if materialised, lead to a change in control of the Company and a mandatory general offer under Rule 26.1 of the Takeovers Code for all the issued Shares (other than those already owned by or agreed to be acquired by the Potential Purchaser or parties acting in concert with it, if any); and (ii) the Company’s monthly update announcement dated 10 August 2026 pursuant to Rule 3.7 of the Takeovers Code. Unless the context requires otherwise, capitalised terms used in this announcement shall have the same meanings as those used in the Announcement.

PROGRESS OF THE POSSIBLE TRANSACTION

The Board wishes to update the Shareholders and potential investors that since the publication of the Announcement, the Potential Purchaser is in the process of obtaining the requisite Outbound Investment Approval from the relevant authorities of the People’s Republic of China. As at the date of this announcement, the discussion between the Vendors and the Potential Purchaser in relation to the Possible Transaction is still ongoing, and the Potential Purchaser and the Vendors have been liaising with the relevant authorities and submitting relevant documents to such authorities in connection with the requisite Outbound Investment Approval; and no agreement or other commitment has been made by the Potential Purchaser in relation to the Possible Transaction.

MONTHLY ANNOUNCEMENT(S)

In compliance with Rule 3.7 of the Takeovers Code, monthly announcement(s) setting out the progress of the Possible Transaction will be made by the Company until an announcement of firm intention to make an offer under Rule 3.5 of the Takeovers Code or of a decision not to proceed with an offer is made. Further announcement(s) will be made by the Company as and when appropriate or required in accordance with the Listing Rules and/or the Takeovers Code (as the case may be).

There is no assurance that the Possible Transaction will materialise or eventually be consummated and the relevant discussions may or may not lead to a general offer under Rule 26.1 of the Takeovers Code. The Possible Transaction may or may not proceed.
